You will be contacted when a decision on your application is made. Applications are presented on a first come first served basis as openings occur.

NEW MEMBER FEES



All new members of the St. Croix Yacht Club are required to pay a one-time fee to the **Capital Investment Fund**. The fund was established to assist in capital improvements and maintenance of our properties. This fee is in addition to the annual dues. The fee for the **Capital Investment Fund is \$2000.00**. New members are allowed to choose a 1, 2, or 3, year payment option for the fund. There will be an annual finance charge of 9% if you choose the 2 pay or 3 pay option.

New Social Members will pay 50% of the current **Capital Investment Fund**. The initial payment of 20% is due with application and the remainder will be due in 20% annual installments for 4 years. **Membership will be revoked if extended payments are defaulted.**
